PRODUCT DEVELOPMENT AND ENGINEERING

1. Product design and/or product development
2. Shop drawings
3. Engineering drawings
4. Engineering calculations, California-stamped
5. Site and vicinity drawings and/or photographs
6. Construction documents
7. Fabric patterning
8. Changes due to unclear Customer-provided construction documents

PRODUCT AND MANUFACTURING

1. Labor and materials to fabricate metal (or other) frame
2. Labor and materials to fabricate fabric cover or membrane
3. Fabric flame retardant certification
4. Frame paint finish or other frame finish
5. Labor and materials to fabricate cables, turnbuckles and related cabling hardware
6. Product assembly
7. One-year limited warranty for labor
8. Manufacturer's limited warranty for fabric
9. Product mock-up, prototype or first article
10. Certificates of Materials Compliance for the project
11. Frame-welding certifications and test reports
12. Fabric certifications and/or test reports
13. Responsibility for the quality and inspection of Customer furnished materials
14. Camera-ready art, color separation, and artwork set-up
15. Graphics application
16. Underside ceiling
17. Internal or external lights
